SECTION V (REACTIVITY DATA)

Welding fumes cannot be classified simply. The composition and quantity of both are dependent upon the metal being welded, the process, procedures and electrodes used. Other conditions which also influence the composition and quantity of the fumes and gases to which worker's may be exposed include; coatings on the metal being welded (such as paint, plating or galvanization), number of welders and volume of work area, quality and amount of ventilation, position of weldor's head with respect to the fume plume, as well as the presence of contaminants in the atmosphere (such as chlorinated hydrocarbon vapors from cleaning and degreasing activities). When the electrode is consumed, the fume and gas decomposition products are different in percent and form from the ingredients listed in Section II. Fume and gas decomposition products, not the ingredients in the electrode, are important. Decomposition products include those originating from the volatilization, reaction, or oxidation of the materials shown in Section II plus those from the base metal, coating, etc. as noted above. Reasonably expected fume constituents would include complex oxides of iron, manganese, silicon, chromium, nickel, molybdenum, calcium, magnesium, and titanium.

One recommended way to determine the composition and quantity of fumes and gases to which worker's are exposed is to take an air sample inside the weldor's helmet, if worn, or in the worker's breathing zone. LC50 and LD50 values are the amount of a substance given to the stated species that cause 50% of that species to die.
